OBJECTIVE

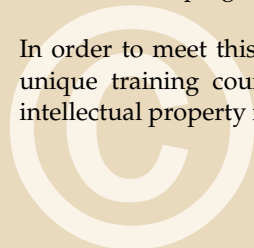
